**Call to Order**

The meeting was called to order at 7:04 p.m. at Brenda and John Duncan YMCA.

**Old Business**

- MSA for the amended (changed typo and corrected USMS portion of 2019 registration fees to \$45) minutes from Gulf LMSC meeting of October 17, 2018.
- Advised those in attendance of amendments to the Gulf LMSC by-laws as presented and explained by Kris and Kevin.

**Officer Reports**

- Chairman (Bruce Rollins):

Welcomed all guests to the meeting and briefly outlined the agenda for the meeting.

- Treasurer (Mark Hahn):

The current ending cash balance as of October 31, 2018 is \$22,787.20 along with \$30,000.00 in CDs for a total of \$52,787.20.

It was confirmed that Bruce Williams would be conducting an independent review of the LMSC financial reports prior to submission of required documentation to the National Office.

Mark distributed the proposed 2019 budget to the meeting attendees for viewing. The written budget showed \$8,450.00 in total income and \$7,890.00 in total expenses for a net excess of \$560.00.

At the meeting, the budget was amended to include the following additional expenses totaling \$5,500.00: ALTS Certification (\$1,500.00), two Gulf representatives to LMSC Conference (\$2,500.00), and Coaching Certification (\$1,500).

With the changes, the 2019 budget shows \$8,450.00 in total income and \$13,390.00 in total expenses for a net deficit of \$4,940.00. Mark explained that the deficit would be covered by the cash on hand and the CDs.

MSA to approve the amended 2019 budget.

- Sanctions (Kris Wingenroth): No report
- Secretary (Kevin Lunsford): No report
- Registrar (Bruce Williams):

As of October 31, 2018, there were 1,263 registered swimmers in the Gulf. As of November 6, 2018, 61 members have registered for 2019. 26 of 31 teams are registered for 2019. Five clubs have not yet renewed their club registrations for 2019. Attrition of about 550 swimmers in the last two years, which follows a trend nationally. The national office is sending out a survey in the first quarter of 2019 to find reasons for the high attrition rate. Bruce Rollins suggested that attrition may be due to lack of communications between Gulf LMSC and non USMS-registered coaches. In a follow-up to the previous LMSC decision to pay the 2019 USMS membership for a non-registered club coach/club contact, said membership must be done through a paper registration so that Gulf LMSC can pay for the contact/coach.

- Top Ten Recorder (Stacy Eicks): No report

- Fitness (Robin Tompkins):

Robin Tompkins discussed the following fitness events for 2019:

Gulf Masters Swim University – January through April  
National Winter Fitness Challenge – February  
Gulf 400 Swim for Time - July  
National Summer Fitness Challenge – August  
Gulf 400 Kick for Time - September  
National Fall Fitness Challenge – November

Robin noted that some fitness swimmers may not like timed events. Carolyn Boak mentioned that the USMS Fitness Challenges lack sufficient structure to motivate some WMST members. Other possible fitness events suggested included completing all three distances of a swim pentathlon or completing all the standard competitive events.

### **New Business**

- Election of Gulf LMSC Officers for a two-year term. Currently on the ballot running unopposed: Chair: Kris Wingenroth; Vice Chair: Kevin Lunsford; Treasurer: Mark Hahn; Registrar: Bruce Williams; Secretary: Karlene Denby. No additional candidates were offered by those in attendance. MSA to elect the aforementioned slate of officers.

- Floor was opened for questions/suggestions on how to make the Gulf LMSC work better for its members.
  - Stacey Eicks reported that Kerry O’Brien was going to provide a clinic for The Woodlands Master Swim Team on January 5, 2019. Gulf members may have a chance to attend this clinic, provided there is space. WMST is

limiting the clinic to 40 swimmers, but encourages any interested coach to attend.

- Russell Hubbard suggested that meets allow unofficial relays combining swimmers from teams that don't have a sufficient number of swimmers to form an official relay.
- Linda Visser mentioned that she preferred meets in which the men and women swim in separate heats.
- There were questions about the team registration on the USMS website. Why are teams only allowed to list USMS certified coaches?
- Appreciation awards were given to out-going chair, Bruce Rollins, and to Mark Hahn for his many years of service as Gulf treasurer.
