



# 2020 Transfer of Club Membership Application

Gulf Region - administered by the Gulf Masters Swim Committee (GMSC)

The date of a transfer is either:

- The date the transfer is initiated by the unattached swimmer
- Or a minimum of 60 days past the last date you last competed for the former club
- Any transfer must be completed prior to the first competition for the new club

The intent to transfer to the club which the swimmer will be competing must be indicated on the meet ENTRY FORM when entry is submitted. Proof that this transfer will be completed by the first day of the meet (60 day unattached period will be completed) must accompany entry form. This proof must be obtained from the registrar in either letter or new card form.
