**FACILITY** San Luis Obispo Swim Center, 900 Southwood Dr, San Luis Obispo, CA 93401

COURSE Pool is a 25 yard by 50-meter, 20 lane outdoor heated pool. 6 to 8 lanes (depending on entries) will be used for the competition and a minimum

of 4 lanes will be used for warm-up/warm down. The competition course has been certified in accordance with 104.2.2(C) on file with USA Swimming. Pool Depth: Start End is 6 ft deep in lanes 1-8 and Turn End is 13 ft in lane 1 to 12.5 ft in lane 8. Ample deck space is available for

structures and seating. \*Bring tie-downs/weights to SECURE your canopies/structures.

**ELIGIBILITY** Open to athletes who are 2021/2022 USA Swimming registered. Registration applications must be received by the meet entry deadline (5:00 PM

on Wed. Nov 10) by meet processor, administrative referee or SCS Office. Late applications will be considered "on-deck" subject to penalties in SCS Swim Guide, Part One, III B. Registration application may be submitted together with entry forms. In SCS age group meets, swimmers 18 & younger must prove birth dates prior to competition. All athletes 18 years or older must complete ATHLETE PROTECTION TRAINING (within

30 days of turning 18), in order to compete.

**CHANGE OF** Before the meet, a swimmer may change affiliation by submitting a CLUB TRANSFER form and the appropriate fee to the Swim Office. At the **AFFILIATION** meet, a swimmer may UNATTACH by notifying the Administrative Referee in writing and paying the appropriate fee. A swimmer may not attach at

the meet.

The meet referee shall be in charge of the meet. Any questions regarding the conduct of the meet should be directed to Ernie Peterson (erniep@kcienv.com).

All coaches on deck must complete the CDC or NFHS Concussion course. Current SCS Meet procedures will be enforced and take precedence **RULES** 

over any errors or omissions on this entry form (see 2021 SCS Swim Guide). After an event has been officially closed, swimmers MAY NOT

CHECK IN OR SCRATCH. Swimmers must swim in their actual Age Group as determined by their age on Nov, 19, 2021.

It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the DISCLAIMER / MAAPP 2.0 conduct of the event. Current USA Swimming rules, including the Minor Athlete Abuse Prevention Policy (MAAPP 2.0) will govern this meet.

The use of audio-visual recording devices, including cell phones, are not permitted in locker rooms, changing areas or restrooms. Recording

devices are not permitted behind the starting blocks during the starting sequence throughout the meet. This meet may be covered by the

media, including photographs, video, web casting and other forms of obtaining images of athletes participating in the meet. Entry into the meet is acknowledgment and consent to this fact.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling DRONES

locker rooms) any time athletes, coaches, officials and/or spectators are present.

**SWIM WEAR** Swimwear must conform to USA Swimming Rule 102.8. Only swimsuits complying with FINA swimsuit specifications may be worn in any USA

Swimming sanctioned or approved competition. DECK CHANGES ARE PROHIBITED.

RACING START Any swimmer entered in the meet unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach

as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Backstroke start wedges will be available for use at the discretion of the athletes.

WARM UP RULES Swimmers warming up or down before and after the meet must be under the direct supervision of a current 2021/2022 USA Swimming coach.

> Warm-up rules will be announced and enforced. Warm-up lanes will be posted for 10&under, Masters, and General warm-up, please obey the warm-up posting in consideration of athlete safety. No diving into the pool except for the sprint lanes directed by the Meet Referee. Marshals will be designated to oversee the warm-up procedure and pool. All swimmers must use 3-point slide entry into the pool during warm-up, no jumping or

**CHECK-IN** Check-in procedures will be sent out, along with the meet information to teams/coaches prior to the start of the meet.

SEEDING All events will be seeded FAST to SLOW. Non-conforming times will be converted for seeding purposes. All events/session will be seeded prior to

the start of each session.

**ENTRY PROCEDURES** Electronic Entry (Preferred Method): Email entry (entry .zip file) will be accepted ONLY when received with an attached Word or .pdf file

including electronic signature of coach and will be dated as official at that time (5PM postmark would gueue before a 10PM electronic). Full payment (single team check) for a team entry must be postmarked within 48 hours of the email entry. Failure to comply will be referred to the Board of Review. Entry updates (added events) will be processed when received by the processor by the entry deadline. Added events for entered swimmers may be submitted by hard copy (this includes email) ONLY. New swimmers accepted by SPACE AVAILABLE. DO NOT RESEND AN ENTRY FILE. A replacement file for the team will not be processed. Deletions will not be refunded. Online Meet Entry: Swimmers may use USA Swimming's OME or Swim Connection to enter online. Entry Card: Submit one SCS consolidated entry card (can be found on SCS

website) per swimmer to enter this meet. Card must be filled out completely including entire USA Swimming registration number. To avoid concern regarding receipt of entry card, enclose a stamped, self-addressed envelope or postcard.

Times submitted must be **BEST RECORDED TIMES** short course or long course from this or preceding swim season (no workout times). SUBMITTED TIMES Coaches and swimmers should be prepared to verify all submitted times. Discrepancy in the submitted times can lead to disciplinary action.

Swimmers must have achieved the minimum time standard listed for an event. If a swimmer does not have a recorded time but is otherwise

qualified, he/she may enter the meet at the non-conforming minimum (see 2021 Swim Guide for exceptions). To compete in OPEN events a swimmer must be at least 11 years old or over as determined by the age on the first date of the meet (Nov 19, 2021) and meet

the stated minimum time standard.

ENTRY LIMIT Swimmers are limited to 5 Individual events per day. Swimmers may not enter BOTH the Novice and Regular Sessions.

Entries will be limited to meet the 4-hour rule.

ENTRY FEE \$4.00 per each INDIVIDUAL EVENT plus a \$10.50 surcharge PER SWIMMER must accompany each individual entry to the address below (not

the swim office). NO REFUNDS. Returned checks will incur a service fee per SCS policy. Deletions will not be refunded. Relay Entry Fee is

\$10 per Relay.

RELAYS Relays can be deck entered. Relays will be swum time permitting. Relay entry fee will be \$10.00 per relay team. Relay Only Swimmers

must pay the meet surcharge (\$10.50) and be entered on the meet entry form by the entry deadline of Nov, 10, 2021.

ENTRIES CLOSE ENTRIES MUST BE RECEIVED BY THE MEET PROCESSOR NO LATER THAN 5:00 PM, WEDNESDAY, NOVEMBER 10, 2021. IF THE MEET

**ENTRY LIMIT** Swimmers are limited to 5 individual events per day.

# City of San Luis Obispo Parks and Recreation Department ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY FOR THE SLO SWIM CENTER

I, the undersigned, understand that the above-named facility and participation in programs offered at the facility sponsored by the City of San Luis Obispo, involves physical activity. I further understand that accidents can occur during my visit to and activities at the SLO Swim Center and that facility visitors can occasionally suffer serious injury or death. I further understand that while City staff and/or volunteers are trained in emergency first aid, CPR, and immediate lifesaving skills, they are not medical professionals and are trained as first responders to respond to immediate emergencies only and not trained to diagnose, monitor or treat chronic, acute or serious medical conditions, whether preexisting or arising out of my visit to or activities at the SLO Swim Center.

I further understand that the above named facility and its programs, sponsored by the City of San Luis Obispo, also involves exposure to other persons, such as other visitors of the facility and City staff, and that visitors of the facility, including myself, can contract communicable diseases, including, but not limited to, COVID-19, while at the SLO Swim Center. I further understand that while City staff and/or volunteers will be trained in, and implement, hygiene, sanitation, and safety measures as recommended by the Centers for Disease Control and Prevention ("CDC") to decrease the likelihood of spreading a communicable disease amongst visitors while at the SLO Swim Center, I, on behalf of a Minor, and/or for myself, assume the risk of contracting any communicable disease by visiting the SLO Swim Center. Nevertheless, I HEREBY ASSUME ALL RISKS OF MY VISITS TO AND ACTIVITIES AT THIS FACILITY.

I hereby waive, release, and discharge the City of San Luis Obispo, its officials, employees, agents and volunteers for any and all claims for damages for death, personal injury, disability, or property of any kind, which may accrue to me as a result of, or arising out of, my participation in recreational programs at this facility This waiver and release is expressly intended to discharge in advance, the City of San Luis Obispo and its officers, employees, agents, and volunteers from and against any and all liability arising out of, or connected in any way with participation in any way with my participation in recreational activities at this facility, now and for all future visits to the facility. THIS WAIVER AND RELEASE WILL APPLY EVEN THOUGH LIABILITY MAY ARISE OUT OF ORDINARY NEGLIGENCE OR CARELESSNESS ON THE PART OF THOSE SO DISCHARGED.
