**Member Input**

Byron Philleo (outgoing board treasurer) requested that the subject of bonuses for the coaches be discussed. Board members voted to conduct an executive session directly following the regular meeting for this purpose.

**Approval of Minutes**

**Board of Directors**

Following discussion, new officers were approved. Greg Stoner will be president; Dave DeYoung will be vice president. Erica Fleishman has been re-elected and will serve as registrar and treasurer. - Heavy lifting: Melanie will get students (small stipend) who can help with setup and tear down.
- Make it fun again: Melanie wants to make it a party that people will remember and want to do again. Ideas include a taco truck.
- Greg gave Melanie the contract that she will review and return.

### **Finance Report**

- Allan reported that the financial outlook is good. 2015 will conclude with a \$19,000 profit, and that we have a reserve of 6 months of operating expenses.
- There has been a slight increase in people requesting their membership be put on hold while we are at Manor Pool.
